

Worthy State Deputy, State Officers, Past State Deputies, District Deputies, Grand Knights and Delegates:

This package contains the resolutions to be voted upon at the 2020 Colorado State Convention. I request that each Grand Knight ensure that the copy is given to the delegates who will represent your council at the state convention. Please discuss these resolutions with your members at your council meetings so that they may provide feedback to your delegates who will be able to make an informed decision and vote according to the desires of your Council.

The delegates for each Council should bring a copy of the resolutions to the State Convention and to any resolutions committee or convention meeting they may attend. No additional copies will be provided at the convention or resolutions committee meeting. This year, a Resolutions Committee meeting will be held at the convention on Friday, April 23, 2020, at the Antlers Hotel (4 S. Cascade Ave, Colorado Springs, CO 80903) – Hayden conference room at 7:30am. This is to ensure that the appropriate amount of time can be spent on the review of all resolutions and informed recommendations can be made by the committee as to each resolution. Any Brother Knight is welcome to attend the meeting, keeping in mind, the committee members are the ones who are charged with making the final recommendations. As with last year, a protocol will be established prior to the start of the meeting to insure that proper decorum for the meeting is maintained.

As a reminder, I am reiterating several points that were included in the initial letter and included with convention forms and information with regard to the submission of resolutions for consideration at the convention and guidelines as they pertain to hospitality rooms and campaigning.

- 1. To comply with the by-laws, the date resolutions must have been submitted and in the hands of the State Advocate for consideration at the annual convention was **February 23, 2020.**
- 2. Hospitality areas <u>WILL NOT</u> open during business sessions, Masses, the banquet and during breaks in the business meetings or any other **OFFICIAL** functions of the Convention.
- 3. Any give-a-way items are to be handed out in hospitality areas and **NOT** on the Convention floor or during business sessions.
- 4. Any signs for campaigning are not to exceed **2 FOOT SQUARE**, are limited to having THREE being posted in the hospitality area. Remember they cannot contain the word **"VOTE"**.
- 5. A campaign sign is any sign that can be interpreted to solicit support for a candidate, council or issue. Additionally, due to legal concerns, the use of any pins or tags containing the Knights of Columbus symbol is not permitted and is addressed by Supreme By-laws, Section 162, part 23.
- 6. The Consent Calendar process will be used for resolutions this year, see reverse side of this letter.

THE CONSENT CALENDAR

PURPOSE: The Consent Calendar is a parliamentary procedure used to deal with non-controversial resolutions, without debate and without voting.

USE: All resolutions are initially placed on the Consent Calendar. Each resolution is called and all non-controversial resolutions remain on the calendar to be automatically accepted or rejected in accord with the recommendation of the Resolutions Committee. All other resolutions are removed from the Consent Calendar for review and debate prior to being voted on.

PROCEDURE: Initially the Chairman of the Resolutions Committee will call each resolution by number and title only, also reading the recommendations of the Resolutions Committee

If there is no objection from the convention floor the Resolution will remain on the Consent Calendar and the recommendation of the Resolutions Committee will be the action of the State Council on said resolution

If there is an objection to the recommendation of the Resolutions Committee or if a delegate wishes to discuss the resolution, he should approach one of the floor microphones, identify himself by name, council name and number and delegate status. He should then state, "I wish to have this resolution removed from the Consent Calendar," or simply state, "Objection." The resolution will then be removed from the Consent Calendar without discussion.

The resolutions remaining on the Consent Calendar at the end of the review will be accepted or rejected according to the recommendation of the Resolutions Committee.

Those resolutions removed from the Consent Calendar will be opened for discussion, debate and other parliamentary procedures at a later time during the business session of the convention. Each side, 'For and Against," the resolution, will be allowed three speakers.

At the call of the Resolution Chairman the delegates will then vote on the resolution all pursuant to Robert's Rules of Order.

RESOLUTIONS – 2020

RESOLUTION #1: DECLARATION OF PRINCIPLES

WHEREAS, it has been 120 years since the first charter was granted to a council of the Knights of Columbus in Colorado, Council 539 in Denver, November 18th 1900; and

WHEREAS, it is appropriate that the Colorado State Council, at its 118th Convention, reaffirm and clearly declare the principles and objectives upon which our Order was founded and upon which principles the Order has prospered and grown in numbers and influence in the State of Colorado being ever mindful that these three factors, are requisite to the support of the Clergy and the Laity.

WHEREAS, the Colorado State Council is tasked with providing engaging programs to be visible and active within our communities and the State; and

WHEREAS, the Colorado State Council sanctions events every year to help get our youth enthusiastic and involved; and

WHEREAS, these events are intended for the fraternal benefit of the Knights of Columbus and not intended to be fundraisers for any subordinate council.

BE IT FURTHER RESOLVED, that the host council of each event meet the minimum insurance liability coverage for their local Diocese requirements - \$1M for the Archdiocese of Denver, \$2M for the Diocese of Colorado Springs, or \$1M for the Diocese of Pueblo; and

BE IT FURTHER RESOLVED, where youth are present, the host council of the event provide a minimum of two Knights that are both Safe Environment certified within their Diocese and within the Knights of Columbus.

WHEREAS, the COVID-19 virus was first detected in Wuhan City, Hubei Province, China and is now impacting over 150 countries worldwide; and

WHEREAS, on February 11, 2020 the World Health Organization announced an official name for the disease that is causing the 2019 novel coronavirus outbreak; and

WHEREAS, coronaviruses are a large family of viruses that are common in people and many different species of animals. Middle East Respiratory Syndrome (MERS) and Severe Acute Respiratory Syndrome (SARS) are two other examples of coronaviruses that originated from animals and then spread to people; and

WHEREAS, the coronavirus disease is not the first pandemic the Knights of Columbus has faced. In the late nineteenth century, and again in 1918, the Knights remained strong and active despite such situations; and

WHEREAS, many people have been infected and while many have recovered, the sick and elderly are most at risk.

NOW, THEREFORE BE IT RESOLVED, that the Knights of Columbus reaffirms our gratitude, support, and encouragement for the men and women of the medical community seeking to help all those infected; and

BE IT FURTHER RESOLVED, that we recognize and extend our appreciation to the US government and all of the commercial institutions for mobilizing and addressing this pandemic so quickly; and

BE IT FURTHER RESOLVED, that the health and well-being of our members and their families, our parishes, and our community is of the utmost importance and that Knights of Columbus councils continue to support them by helping to provide food for the sick and elderly, assistance where needed and checking on all Brother Knights and their families; and

BE IT FURTHER RESOLVED, the Knights of Columbus is fully committed to all Brother Knights and their families to continue our important work— from protecting the faith and financial stability of members' families, to helping members put their faith into action by providing important charitable service within their communities; and

BE IT FURTHER RESOLVED, the during this unchartered time every member and his family is urged to pray the Supreme Council's novena based on the prayer of Pope Francis as well as a prayer being promoted by the United States Conference of Catholic Bishops.

WHEREAS, many of these men and women have heroically given their lives or sustained serious or debilitating injury while deployed in the service of their country; and

WHEREAS, over 400,000 veterans and 45,000 active/reserve Armed Forces members live in the State of Colorado, a presence in nearly every Knights of Columbus Council in the State; and

WHEREAS, the Knights and families of the Colorado jurisdiction have a great appreciation of the sacrifices of the Men and Women of the Armed Forces, veterans and their families.

NOW, THEREFORE BE IT RESOLVED, that the Colorado Knights of Columbus reaffirms our unequivocal gratitude, support, and encouragement for the men and women of the armed forces who defend our liberties and freedoms; and

BE IT FURTHER RESOLVED, that we remain steadfast in our commitment to recognize the contributions of every service member on Active Duty, in the Guard, in the Reserves, and all veterans and retired service members; and

BE IT FURTHER RESOLVED, that the delegates assembled at this year's Colorado State Council Convention, rise and show it's appreciation for the Members of the Armed Forces, our veterans and their families; and

BE IT FURTER RESOLVED, that we now pause in our deliberations to pay tribute to those men and women who have suffered serious combat injuries and to pray for the souls of those who have paid the ultimate sacrifice by giving their lives in the defense of the nation.

WHEREAS, this Order-wide initiative is meant to strengthen our parishes and foster greater unity and WHEREAS, the order has already been moving toward answering this call through the development of thousands of new parish-based councils; Various new programs to strengthen family life all leading to a deeper understanding of the family as a domestic Church; and an increasing commitment to serve the Church's mission of a new evangelization through the parish.

THEREFORE BE IT RESOLVED, we will focus more on programs that support Catholic families in their mission as a domestic Church.

RESOLUTION #19: BUILDING A CULTURE OF LIFE

WHEREAS, the Knights of Columbus has a deep and historic commitment to oppose any governmental action or policy that promotes abortion, embryonic stem cell research, human cloning, euthanasia, assisted suicide, or other offenses against life; and,

WHEREAS, the Order supports programs that provide women facing crisis pregnancies with alternatives to abortion, including adoption, and that we support projects that provide spiritual support to those women suffering from the traumatic emotional and psychological aftereffects of abortion; and

WHEREAS, our Ultrasound Program has provided a window to the womb by placing more than 1,000 ultrasound machines in 50 states and Canadian provinces; and

WHEREAS, we reaffirm our commitment to building a "culture of life" by promoting policies that favor the family, and by recognizing that it is within strong and healthy families that moral values are taught and the spiritual heritage of the nation is transmitted; and,

WHEREAS, the Knights of Columbus has a long history of supporting marches and rallies for the cause of life; and

WHEREAS, Pope Benedict XVI reiterated that "Catholic politicians and legislators, conscious of the grave responsibility before them, must feel particularly bound, on the basis of a properly formed conscience, to introduce and support laws inspired by values grounded in human nature;" and

WHEREAS, in *Evangelii Gaudium*, Pope Francis reminded us that, "Among the vulnerable for whom the Church wishes to care with particular love and concern are unborn children, the most defenseless and innocent among us...this defense of unborn life is closely linked to the defense of each and every other human right. It involves the conviction that a human being is always sacred and inviolable, in any situation and at every stage of development;" and,

WHEREAS, in his encyclical, *Laudato Si'*, the Holy Father reiterated that "Since everything is interrelated, concern for the protection of nature is also incompatible with the justification of abortion."

NOW, THEREFORE BE IT RESOLVED, that we believe women deserve better than abortion and will continue to support crisis pregnancies with alternatives to abortion, including adoption, and that we support projects which provide spiritual support to those women and men suffering from the traumatic emption and psychological aftereffects of abortion; and

BE IT FURTHER RESOLVED, that the Knights of Columbus will continue to uphold the Catholic Church's authoritative teaching on the sanctity of life from conception to natural death, as explained in the *Catechism of the Catholic Church, Laudato Si'*, and other documents; and

BE IT FURTHER RESOLVED, that we reaffirm our long-standing policies of not inviting to any Knights of Columbus event, persons, especially public officials or candidates for public office, who do not support the legal protection of unborn children, or who advocate the legalization of assisted suicide or euthanasia, and that we prohibit such persons from renting or otherwise using facilities over which our members have control, or speaking at Knights of Columbus events, or bestowing on them honors or privileges of our Order of any kind, or inviting them to serve as honorary chairpersons of events, celebrations, or committees, or hold any office in the Knights of Columbus; and

BE IT FURTHER RESOLVED, that we once again commit ourselves to praying the Rosary frequently, to fasting and to doing penance in reparation for the evils perpetrated against the gift of life and that we seek the

intercession of the Blessed Virgin Mary, who herself said "yes" to life, to intercede on our behalf for the establishment of a "culture of life;"

RESOLUTION #20: IN SOLIDARITY WITH PERSECUTED CHRISTIANS

WHEREAS, Christians are suffering violent persecution around the world, especially in Iraq and Syria, as a result of sectarian violence and civil war; and

WHEREAS, the number of Christians in Iraq once numbered over 1 million, but has now dwindled to an estimated 200,000 as the result of violence and armed conflict; and

WHEREAS, the eight-year civil war in Syria has led to the death of over 500,000 people, the displacement of 7.6 million, and caused 3.9 million refugees to flee the country, including many Christians; and

WHEREAS, many nations have remained largely silent in the face of unspeakable violence and persecution; and WHEREAS, Pope Francis has urged the international community to respond to this immense humanitarian tragedy; and

WHEREAS, Pope Francis has spoken of the significant contributions Christians have made to the Middle East and the importance of their continued presence in the region; and

WHEREAS, the Knights of Columbus established the Christian Refugee Relief Fund to aid persecuted Christians in Iraq, Syria and the surrounding region.

NOW, THEREFORE, BE IT RESOLVED, that the Knights of Columbus stands in solidarity with all Christians around the world who are suffering from violent persecution, and we call on all Christians and people of good will to do the same; and

BE IT FURTHER RESOLVED, that we commend the nations protecting those religious minorities seeking refuge from persecution in Iraq and Syria, and call on all governments and legislative bodies around the world to recognize the ongoing genocide against Christians and other religious minorities and to assist these persecuted communities; and

BE IT FURTHER RESOLVED, that the Colorado Knights of Columbus pledges to continue to provide assistance to those who have been victims of crimes against humanity, especially those Christians who have been violently persecuted because of their faith.

RESOLUTION #21: IN DEFENSE OF RELIGIOUS LIBERTY

WHEREAS, the Second Vatican Council declared in Dignitatis Humanae that the right to religious freedom is based upon the inherent dignity of the human person which requires that all people are to be free from coercion in matters of belief and conscience, and that no one should be forced to act in a manner contrary to his or her own beliefs or conscience; and

WHEREAS, the right to religious freedom is guaranteed by the First Amendment of the Constitution of the United States, the Universal Declaration of Human Rights, and other documents recognizing religious freedom; and

WHEREAS, Pope Francis has called religious freedom, "a fundamental right of man," that is "not simply freedom of thought or private worship," but "the freedom to live according to ethical principles, both privately and publicly...;" and

WHEREAS, the Knights of Columbus since its founding has worked to defend religious freedom for Catholics and all people, and has done so out of our commitment to our faith and our unshakeable belief that religious freedom is a basic civil right; and

WHEREAS, our work for religious liberty includes activities to protest the persecution of Catholics in Mexico in the 1920s, as well as efforts to combat the anti-religious worldview of Communism, and the inclusion of the

BE IT FURTHER RESOLVED, that we stand firm in our conviction that the full guarantee of religious liberty cannot be limited to "freedom of worship" as some have attempted, but must include full "freedom of religion," which encompasses the public dimension of religion, the freedom from persecution or discrimination on the basis of conscience and belief, and the fact that believers are called to play an active role in building the social order; and

BE IT FURTHER RESOLVED, that we will remain steadfast in our opposition to future governmental actions or policies that force institutions and individuals to violate their most deeply held moral and religious convictions; and

BE IT FURTHER RESOLVED, that our struggle for religious freedom is not only for our sake, but for the sake of our children, our grandchildren and all future generations, so that they too may know a country that is "one nation under God, indivisible, with liberty and justice for all."

NOW, THEREFORE BE IT RESOLVED, that the Knights of Columbus stands in solidarity with Pope Francis to combat human trafficking; and

BE IT FURTHER RESOLVED, that we continue to pray for the victims and families of this terrible crime; and

BE IT FURTHER RESOLVED, that the Knights of Columbus advocates for solutions to prevent and end all forms of human trafficking and modern slavery around the world; and

BE IT FURTHER RESOLVED, that we call upon all Colorado officials to enact legislation that will find lasting solutions to prevent labor and sex trafficking, hold perpetrators accountable, ensure justice for victims and empower survivors with tools for recovery.

BE IT FURTHER RESOLVED, that the Colorado State Council provide delegates of those councils participating in the football sweepstakes by collecting donations of a minimum of \$600 (60 tickets), in lieu of mileage and per diem, a voucher in the amount of up to \$60 for a single person and up to \$120 for a couple toward the Convention activities, i.e. Banquet, luncheons, clergy appreciation dinner, etc. for the 2021 State Convention, provided the delegates whose councils are located outside a commuting-radius of 20 miles from the hosting hotel of the state convention, lodge Friday and Saturday nights at the hotel hosting the state convention; and

BE IT FURTHER RESOLVED, that the Colorado State Council provide the Elected State Officers, Past State Deputies, widows of Past State Deputies and District Deputies, in lieu of mileage and per diem, a voucher in the amount of up to \$60 for a single person and up to \$120 for a couple toward the Convention activities, i.e. Banquet, luncheons, clergy appreciation dinner, etc. for the 2021 State Convention, provided if they are located outside a commuting-radius of 20 miles from the hosting hotel of the state convention, lodge Friday and Saturday nights at the hotel hosting the state convention.

RESOLUTION #25: PER CAPITA AND ANNUAL ASSESSMENTS

WHEREAS, the Colorado State Council has sought to efficiently manage the state budget by seeking ways to defray increasing operational costs incurred in day-to-day operations, conducting the football sweepstakes as a fund raiser is one way; and

WHEREAS, it should be the goal of every council in the state to provide the Colorado State Council with an effective and efficient operational budget so as to promote the principles of our Order, maintain a growth in membership while acting as the right arm of the Church; and

WHEREAS, the Knights Call assessment was originally created to offset the costs of printing and mailing the Knights call. Today, the Knights Call is created and distributed electronically to the State and every council is currently assessed \$46 for the Knights Call annually (\$23 per semiannual billing); and

WHEREAS, every council is currently assessed \$10 to help pay for sending delegates to the Supreme Convention annually (\$5 per semiannual billing); and

WHEREAS, the Colorado jurisdiction has had 2nd and 3rd degree traveling teams to administer the major degrees; and

WHEREAS, Supreme has changed the degrees to create a new Exemplification of Charity, Unity and Fraternity which no longer requires traveling degree teams, but instead the State has created training teams to travel and train councils on how to perform the new degree. Every council is currently assessed \$0.50 per member to support our State Ceremonial teams annually (\$0.25 per member, per semiannual billing).

THEREFORE, BE IT RESOLVED, that for the fraternal year 2020/2021, the per capita assessment be maintained at its current level at \$8.00 per active member and \$4.50 per inactive insurance member as listed on their membership rolls as of July 1, 2020 and January 1, 2021 (\$4.00 and \$2.25, respectively, per semiannual billing); and

BE IT FURTHER RESOLVED, that for the fraternal year 2020/2021, the per capita assessment for those councils who wish to participate in the football sweepstakes fundraiser by collecting donations of a minimum of \$600 (60 tickets), be rewarded for their efforts with their per capita set at \$7.00 per active member and \$4.00 per inactive insurance member (\$3.50 and \$2.00, respectively, per semiannual billing) as listed on their membership rolls as of July 1, 2020 and January 1, 2021. The 60 tickets sold nets an additional \$120 for the council in addition to the \$1.00 (\$.50 semiannual) discount on the per capita; and

BE IT FURTHER RESOLVED, that for the fraternal year 2020/2021, the annual Knights call assessment remain unchanged at \$46 per council annually (\$23 per semiannual billing), but be renamed to the "State Communications Assessment". This assessment goes towards the costs of building the Knights call, electronic distribution and the costs of any other communications to the jurisdiction; and

BE IT FURTHER RESOLVED, that for the fraternal year 2020/2021, the annual Supreme Delegate assessment remain unchanged at \$10 per council annually (\$5 per semiannual billing); and

BE IT FURTHER RESOLVED, that for the fraternal year 2020/2021, the annual Ceremonial assessment of \$0.50 per member (\$0.25 per member, per semiannual billing) remain unchanged, but be renamed to "Ceremonial and Training Assessment".

"Section 1: The State Council shall be composed of the following members, all of whom must be in good standing: The State Council shall consist of The Grand Knight and a Past Grand Knight actually residing in the jurisdiction of Colorado from each subordinate council in good standing, the State Officers exofficio during the terms of their office and the last living Past State Deputy, provided, however, that when the last living Past State Deputy is actually residing in another state or jurisdiction, he shall thereby forever forfeit such right and his nearest predecessor actually residing in this jurisdiction shall be entitled thereto. If there be more than one Past Grand Knight, the subordinate council shall elect the one to represent it in the State Convention. A council having no Past Grand Knight may elect one of its third degree members in good standing in lieu thereof, as a representative of said council in the State Council. Each subordinate council shall elect alternates, from among its third degree members living in Colorado, for its representatives in the State Council. Such elections shall be held not later than the first regular meeting in March of each year."; and BE IT FURTHER RESOLVED, the Colorado State Council By-Laws, Article IV, Section 4 be removed:

"Section 4: During January of each year, the State Deputy may submit to the subordinate councils of this jurisdiction a resolution to provide that upon its adoption by a majority of the councils, any council in this jurisdiction may be represented at the succeeding meeting of the State Council by the Grand Knight, or in his absence, a duly elected Past Grand Knight or by the alternate of one of them, who shall be entitled to two votes on any matter coming before the meeting. If the State Deputy does not submit such resolution to the subordinate councils of this jurisdiction on or before February 1st, the State Secretary shall do so upon request in writing from the Grand Knights of ten percent of councils, but not less than two councils. If the resolution is adopted by a majority of the councils within the jurisdiction, on or before March 31st, it shall be in effect at the next meeting of the State Council. In cases where the resolution is passed, the expenses of only one representative from each council shall be paid out of the State Council funds."

Officers of the State Council shall hold office for a term of one year from and after the 1st day of July following their election and until their successor has been elected and qualified."

WHEREAS, this change will further align the State Council with the Supreme Officer's responsibilities.

NOW THEREFORE, BE IT RESOLVED: the Colorado State Council By-Laws, Article VI, Sections 2 and 3 be changed to read as:

"Section 2: The State Secretary shall keep a true and faithful record of all proceedings of the State Council and meetings of the State Officers and keep an account of the financial affairs of said body. He shall furnish all subordinate councils within the jurisdiction a credential blank for use of delegates to meetings of the State Council by March 1st prior to said state meetings. The blank shall be returned to the State Secretary by April 1st before the state meeting. From the credentials so returned to him, the State Secretary shall prepare a temporary roll call of the State Council, which shall be the roll call until the report of the committee on credentials is received and adopted. He shall draw all warrants for payment of bills against the State Council and said warrants shall be countersigned by the State Deputy. He shall receive all moneys due the State Council and shall pay over the same to the State Treasurer within 10 days. He shall, by January 31st and July 31st of each year, within thirty days of the adjournment of the State Council notify all subordinate councils within the jurisdiction of the State per capita assessment. He shall publish, through any manor approved by the State Council, cause to be printed a report of the proceedings of the meetings of the State Council, the same to be certified to by the State Deputy. copies thereof shall be furnished to each subordinate council within the jurisdiction. He shall also perform such other duties as may pertain to the office of Secretary and shall be presiding officer when the State Deputy is absent from the State Council hearing."

"Section 3: The State Treasurer shall receive all monies due the Order, and give receipts to the State Secretary all monies so received being in appropriate form payable to the Colorado Knights of Columbus, which he shall then deposit into an approved bank or other approved secure institution of deposit within this jurisdiction, receive, take charge of, and deposit all moneys of the State Council in an approved bank or other secure institution of deposit within this jurisdiction, selected and agreed upon by the elected state officers in the name of the State Council. The State Treasurer shall pay all warrants regularly drawn upon him by the State Secretary when countersigned by the State Deputy and no other. The State Treasurer shall also report at the annual meeting of the State Council, and at regular meetings of the State Council and State Officers, or upon the request of the State Deputy, the amount of receipts and disbursements, in such form as shall be approved by the State Officers."

All proposed bylaws changes shall be distributed by the State Advocate through the US Mail and postmarked not less than thirty days prior to the opening of the convention. The State Advocate shall distribute all proposed by-law changes to the State Officers and subordinate councils by e-mail, US mail or any manor approved by the State Council not less than 30-days prior to the opening of the convention."

Source of these funds include, but are not limited to, funds remaining in the General Account in excess of \$50,000 on June 30th of any year., net annual proceeds from the Country Store, Pennies from Heaven, and income from other State Council fund raisers. This fund will be used only for charities of the State Council. The disbursement of these funds will require a two-thirds vote of the Elected State Officers including the Immediate Past State Deputy.

Those funds in reserve on June 30 of any year, in excess of \$50,000, be transferred to the Colorado Knights of Columbus Charities, Inc. for charitable purposes."

BE IT FURTHER RESOLVED: the Colorado State Council By-Laws, Article X, Section 6 be removed: "Section 6: The Keep Christ in Christmas Program, Degree Team accounts and Knights Call shall carry a balance from year-to-year and funds in these accounts will be used only for their intended purposes."

(Said resolutions, submitted by a subordinate council shall be submitted over the signatures of the Grand Knight and the Recording Secretary of the submitting council, showing date of first reading and the date of second reading, and passage by the council. Resolutions will be distributed by the State Advocate through the US Mail postmarked not less than thirty days prior to the opening of the convention.) The State Advocate shall distribute all resolutions to the State Officers and subordinate councils by e-mail, US mail or any manor approved by the State Council not less than 30-days prior to the opening of the convention. All resolutions, except bylaw revisions, require a majority vote of the convention for approval. At times, under extenuating circumstances and at the discretion of the State Advocate, resolutions other than those following the above procedure may be presented directly to the resolutions committee and/or the floor of the convention. These, if presented, shall require a two thirds majority vote for ratification.", and

BE IT FURTHER RESOLVED, the Colorado State Council By-Laws, Article XIV, Section 4 be removed:

<u>"Section 4</u>: The State Secretary shall have a report of the State Council meeting reproduced prior to and shall distribute that report (proceedings) at the Organizational Meeting following the said State Council meeting. One copy of said report shall be furnished to each Elected State Officer, past State Deputy and subordinate council."

WHEREAS, particular program events can and should be managed through State council resolutions or guidelines and they should not be listed within the bylaws itself.

NOW THEREFORE, BE IT RESOLVED, the Colorado State Council By-Laws, Article XXI be removed:

"Article XXI - Ongoing Programs of the State Council

Section 1: The Colorado Knights of Columbus will facilitate a Keep Christ in Christmas Program based on subordinate council participation under the direction of the State Deputy and the State Council Keep Christ in Christmas Chairman. Funds resulting from this program will be administered in compliance with Article X, Section 5.

Section 2: The Colorado State Council, in conjunction with the Colorado Knights of Columbus Charities, Inc., has charitable programs including the "Pennies From Heaven Program", the "Father McGivney Club", and the "Perpetual Memorial Society" for charitable purpose. Each is managed in compliance with the bylaws of the Colorado Knights of Columbus Charities Fund, Inc."

BE IT FURTHER RESOLVED, the Colorado State Council By-Laws, Article XXII be removed:

"Section 1: From time to-time, the delegates assembled may approve certain State Council sanctioned events (softball, bowling, free throw, golf tournaments) and/or the right to host major degrees. These events are intended for the fraternal benefit of the Knights of Columbus and not intended to be fund-raisers for any subordinate councils. Any subordinate council may bid such an event and may charge reasonable entry fees in compliance with the guidelines of the Colorado State Council for that event.

The bowling tournament shall be held on either the last or second to last weekend in February.

The softball tournament shall be held on either the last or second to last weekend in June.

The golf tournament shall be held on either the last or second to last weekend in July.

The State Free-throw Contest shall be held on either the last or second to last weekend in March.

The State Deputy shall approve the actual date of each event prior to any distribution of information regarding that event.

Section 2: The State Council shall develop specific minimum guidelines for hosting athletic events. When bidding to host an athletic event, the council submitting the bid is required to demonstrate how they anticipate meeting said standards.

<u>Section 3</u>: Within sixty days following a subordinate council hosted event, financial reports shall be submitted using the forms provided by the State Council to the State Deputy. The reports from each event shall be included in the proceedings of the subsequent State Convention."
